- A. **HSAB Adopt---A---Street Cleanup on Sat, 9/18:** Scott Crew to share updates and plan for HSAB members cleaning up Rocky River Rd on 9/18 - and Town social media sharing cleanup-related content.

Will also explore options to fund and install a permanent PurpleAir monitor to this park (currently no wifi available at this park). Need to assign an HSAB point person to this.
- F. **Wildlife (deer) in a section of Stallings Farm:** Per what a resident in Stallings Farm shared with Councilmember Ron Smith, recently, the deer population has increased more than is historically there. No updates to share. Discuss possible organizations to contact for recommendations.
- G. **Possibility to replace existing Harrisburg waste and recycle bins:** Follow up with Mayor Sciascia and Town staff (Brian Lee, Lee Connor, Rob Donham) needed. Continue exploration to determine if replacing these bins ASAP would be cost neutral within the Town's existing Waste Pro contract. If so, proceed accordingly. If not, weigh cost options to replace them before the contract ends or plan to replace them when the contract ends on June 30, 2024.
- H. **HSAB-funded PurpleAir monitor in Pharr Mill Park:** Per conversations with James Mahoney (Town IT staff), due to logistics/infrastructure, the decision was made to install this monitor in Pharr Mill Park. James has the monitor and it should be installed in September (timing TBD). Discuss HSAB member payment options (one option - each member pays CleanAIRE NC directly).
- I. **"Green Leaf" Program (business and residential):** Updates and next from 8/25 HSAB working session to be shared - two main outcomes: keep the Green Leaf name and greatly simplify the program (for the Year 1 launch at least). Next steps: Individual member feedback by Sunday, 9/12 EOD; Sub-committee (Noel, Crew, Huster, anyone else?) to tighten up approach/documents by or before 9/26 EOD; Then begin outreach/engagement with some Town staff, businesses (HBA), and residents for feedback. Goal is to officially launch in January 2022 (pre--promote in late Q4 2021 if possible).
- J. **Harrisburg water quality:** Scott Noel to share brief update and possible local resource to assist with water quality information/education. Further engage Town staff (Public Works) and other experts (local and state) on water quality - specifically, on how to help further educate residents. (Need an HSAB member on point to drive this.)
- K. **New EV charging station installed and live at Harrisburg Park:** Went live the week of August 23, 2021. Need to work with Brian Lee and the NC DEQ (as part of the rebate program agreement) to plan an official "ribbon cutting ceremony" for this - could be related to or separate from the 9/25 NDEW event.
